

**TERMS AND CONDITIONS FOR PURCHASE OF FOREIGN/INDIAN MEDICAL BOOKS FOR THE  
YEAR 2011 – 12**

1. The books supplied should be of the latest edition. The supplier will have to certify that the books supplied are of latest edition.
2. The tender should accompany the earnest money of Rs. 30,000/- in the shape of call deposit receipt/FDR drawn on any scheduled/nationalized bank duly pledged in favour of Registrar, Pt. B.D.Sharma University of Health Science, Rohtak payable at SBI Medical College, Rohtak. In case order is not placed, the earnest money will be refunded, other than the highest discount supplier to whom the supply order of books is to be issued.
3. The supply is to be made by the vendor at Library, PGIMS, Rohtak with in 90 days from the date of issue of supply order.
4. The validity of the tender is one year.
5. The conversion rates of G.O.C. for Foreign Currencies will be applicable on the date of issue of supply order or receipt of books which ever is less.
6. The vendor will quote the maximum Flat/Consolidated rates of discount on Foreign/Indian Medical Books. The undersigned reserve the right for negotiation if considered necessary. The conditional tenders shall not be accepted.
7. The tender received without earnest money or after the due date and time shall not be entertained.
8. In case the price is not printed on the Book, the proof of price may be supplied with the Bill, otherwise delivery will be rejected.
9. The Books found defective and not of latest edition will be rejected and the same will have to collect at your own cost and replaced with in one month.
